

## KAILUA CANOE CLUB PRACTICE COVID-19 WAIVER

Subject to guidelines, oversight, and approval, and the procedures and conditions set forth below, Kailua Canoe Club (or the “Club”), will allow Club members (or the “Members”) in good standing (e.g. dues current, a current and signed HCRA and 2022 Club Waiver), to participate in outrigger canoe practice sessions (each a “Practice” and together the “Practices”) and races (each a “Race” and together the “Races”) during COVID-19. The requirements for Practice and race participation may change at any time as federal and/or state policies and guidelines change. Violating the COVID-19 procedures and conditions may result in exclusion from Practices and Races, or termination of Club membership.

Club members will conform to Federal (i.e., Centers for Disease Control and Prevention) and State of Hawaii COVID-19 guidelines, and City & County of Honolulu COVID-10 guidelines (as these guidelines change frequently, please click the links to understand what current guidelines are, and revisit often to see how they change over time).

Club members will follow all KCC General COVID-19 Rules and Procedures set forth by Kailua Canoe Club coaches.

Despite these measures Kailua Canoe Club cannot guarantee that Members or Members’ family members will not become infected with COVID-19. By signing this waiver, Members acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I or my family members may be exposed to or infected by COVID-19 by attending Practices and Races and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I also acknowledge and understand that I must comply with all Club procedures to reduce the spread while attending Practices and Races and that the Club cannot guarantee that I will not become infected with Covid-19 as a result of participating in Practices and Races.

That the risk of becoming exposed to and/or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club Board members, Club members, volunteers, and other participants and their families.

I further attest that I will not attend Practice if:

I, or any of my family members, are experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.

I, or any of my family members, have been diagnosed with Covid-19 unless cleared as non-contagious by state or local public health authorities.

I, and my family members, are not following all Federal, state and/or local recommended COVID-19 guidelines.

I hereby release and agree to hold Kailua Canoe Club harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the Club, or that may otherwise arise in any way in connection with participating in Practices or Club activities. I understand that this release discharges Kailua Canoe Club from any liability or claim that I, my heirs, or any personal representatives may have against the Kailua Canoe Club with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, Kailua Canoe Club Practices or activities. This liability waiver and release extends to Kailua Canoe Club together with all Board Members, Club members, volunteers, or other Club participants.
